ADMINISTRATIVE ORDER CONCERNING
FEDERAL GOVERNMENT SHUTDOWN

Certain agencies that appear before our Court may be subject to the current federal government shutdown. This could affect those agencies' ability to take record action prior to deadlines in cases and proceedings pending in our Court. Given these circumstances, the Court deems it appropriate to extend the time for such responses that have or will come due during the shutdown. Accordingly, it is

ORDERED that the time is enlarged for any federal agency affected by the current federal government shutdown to take record action within seven days after the shutdown ceases.
